In 1996, the Lake Pontchartrain Basin Foundation, in cooperation with the U. S. Geological Survey, prepared a comprehensive bibliography of the environmental and geological literature on the Lake Pontchartrain Basin. This bibliography proved to be quite useful to anyone doing research on the Basin. However, the bibliography was incomplete and several important references were omitted. In addition, it has rapidly become out-of-date with new publications appearing constantly. The following is an initial attempt to update the bibliography. It should not be regarded as final, nor complete, but will need to be updated frequently. Hopefully this can become an on-going project of the Basin Foundation, with updated versions issued at regular intervals. Anyone noting significant omissions is requested to inform the Basin Foundation of such omissions.
